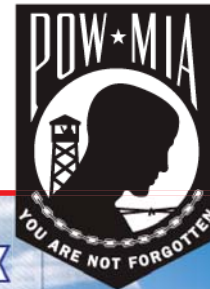

Legislative Update

December 5, 2016

As of this writing President Elect Trump has not chosen a VA Secretary for his new cabinet. In a recent meeting with Trump transition staff, representatives from thirty-one veterans' organizations pressed the incoming administration for the need to keep most VA services in house and resist efforts to expand the Choice program to every veteran thereby depleting resources and patients from the VA system. VVA's Rick Weidman, Executive Director for Policy and Government Affairs told the new administration "You ain't seen nothing yet if you send people to the private sector" (*Washington Post, Power Post, 1 December 2016*) The new administration has made campaign statements to indicate they favor proposals that would expand the choice program but has not yet explained how it would be paid for or how to address the cost to the VA health care system.

VVA National President John Rowan has published an open letter to both President Obama and President Elect Trump asking them both to use their executive action to administratively change the bad discharges many combat veterans got under the so called Personality Disorder diagnosis. These discharges are considered "bad paper" and

make these veterans ineligible for services from the VA that they may need to address conditions that were the result of their service. PASSED Unanimously (week of December 10) — Miller-Blumenthal Veterans Health Care and Benefits Act of 2016. This legislation contains all the language of the *Toxic Exposure Research Act of 2015*, of which Vietnam Veterans of America was a strong supporter. Here is a statement from VVA national President John Rowan's press release:

"This legislation, a necessary first step, has been a top priority for VVA. It will lay the groundwork for the research we need on the health of our children and grandchildren, whom we believe have been impacted by exposures during our military service—and in keeping with our founding principle: Never again will one generation of veterans abandon another—this legislation will ensure that our newer veterans will not have to wait 50 years for answers." <https://vva.org/wp-content/uploads/2016/12/VVA-Press-Release-16-34.pdf>
