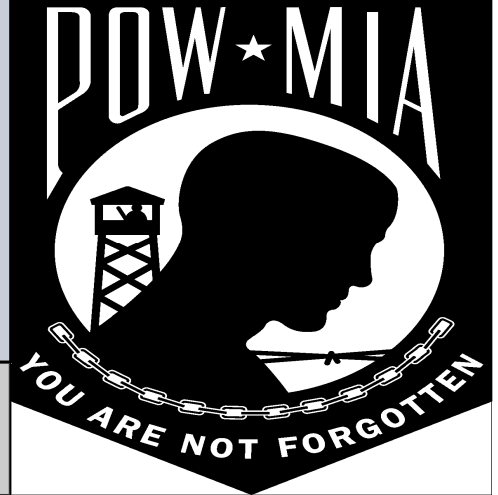

AMERICANS ACCOUNTED FOR: There still has been no published change to the number unaccounted-for since the April 10th Update. For various reasons, including wishes of the family, DoD announcements are often delayed far beyond the ID dates, meaning other IDs are likely pending. Several of those named this year were examples of how remains repatriated many years ago can now be identified using contemporary science that wasn't available in earlier years. The number of Americans now listed by DoD as returned and identified since the end of the Vietnam War in 1975 is 956. Another 63 US personnel, recovered by the US and identified before the end of the war, bring the total of US personnel accounted for from the Vietnam War to 1,019. Of the **1,627** still unaccounted-for, 90% were lost in Vietnam or in areas of Cambodia and Laos under Vietnam's wartime control: Vietnam-1,269 (VN-467, VS-802); Laos-302; Cambodia-49; PRC territorial waters-7. These country-specific numbers can and do fluctuate due to investigations resulting in changed locations of loss. Since formation in 1970, the League has sought the return of all POWs, the fullest possible accounting for those still missing, and repatriation of all recoverable remains.

NEW DPAA DIRECTOR NAMED & NOW MOVING FORWARD! LTG (Ret) Mike Linnington, USA, was named Director, Defense POW/MIA Accounting Agency (DPAA), and sworn in just before the League's 46th Annual Meeting. While always cautious to not overstate support for people named to positions of responsibility in the POW/MIA accounting mission, it is no overstatement to recognize his outstanding, varied background.

Important now are the several steps he has already taken that clearly reveal he is moving energetically, though thoughtfully, to follow the directive issued by former Secretary of Defense Chuck Hagel to "completely reorganize" the POW/MIA accounting community. While structural change is always rife with turmoil and uncertainty, Mr. Linnington is moving out smartly. His restructure plans, though still evolving, appear to be dramatically moving the mission forward and, importantly, are adhering to Secretary Hagel's directive to "build on the existing strengths" of the accounting process. As a result, he is moving beyond the recommendations he received from Vice Admiral Michael Franken, USN, whose vision for DPAA related more to a concept for production of "products" than to a viable plan to pursue accounting objectives for missing US personnel and their families.

Already confirmed is that former JPAC Detachments in Thailand, Vietnam and Laos will continue to be Detachments 1, 2 and 3, respectively, reporting to incoming Deputy Director, BG Mark Spindler, USA. Long-serving civilian specialists in the Detachments, recognized as indispensable, are expected to be extended indefinitely. The small contingent of personnel deployed to support operations in Europe will also continue as a Liaison Office, possibly reporting to a European Regional Director. Placement in the new structure of the Joint Commission Support Directorate (JCSD) is not yet known, but has unique status due to supporting the US-Russia Joint Commission (USRJC) on POW/MIA Affairs, with a presidentially named Chairman, General Robert "Doc" Foglesong, USAF (Ret).

There is also a very high priority being placed on success of the Public Private Partnership (P3) initiative, viewing the broad areas in which potential partnerships (public/private, public/public, tri-party, etc.) could be formed as a means to augment the experienced field assets and resources that have focused primarily on Vietnam War accounting. P3 offers significant opportunities to expand the overall accounting efforts to produce results more rapidly through applying some contractors' efforts to archival research, investigations and recoveries that pertain mostly to WWII, Korean War (disinterment and IDs) and Cold War loss incidents.

A symposium was held in Hawaii, immediately following the “Blessing & Dedication Ceremony” on July 27th. League Chairman of the Board Ann Mills-Griffiths represented the POW/MIA families by helping to cut the traditional lei. Following the formal raising and permanently-lighted posting of the US, POW/MIA and State of Hawaii flags and an invocation by a Navy Chaplain, Director Linnington gave remarks, followed by the late Senator Daniel Inouye’s long-time Chief of Staff, Jennifer Sabas, whose remarks were inspirational. Prayers and blessings by a native Hawaiian clergyman concluded with the PACOM Band playing the Military Service Songs, after which a reception was held in the front foyer of the new, incredible DPAA building. The League sincerely thanks dedicated civilian Johnie E. Webb, Jr., retired Army LTC, former Commander of the Central Identification Laboratory, Deputy to the Commander of JPAC, and currently Interim Deputy Director of External Communications for DPAA. His long battle, fully supported by the League, to see completion of the new DPAA building has finally ended in success. We can only hope that his historic dedication to the accounting mission will be rightfully rewarded in the new DPAA structure.

This symposium began on July 28th and was scheduled to provide an opportunity for DPAA leaders, including interim-appointed Directors and Deputies, to utilize the newly improved restructure as the basis for helping to determine a viable sub-structure, moving tasks and numbers of personnel as required, but getting to a nearly finalized structure. Final structural decisions are expected as early as Friday, August 7th, but it is anticipated that full operational capacity won’t be reached until the end of this year or in January, 2016. Having said that, Mr. Linnington has stated his expectation that there will be in-process reviews, assessments and, potentially, adjustments as implementation occurs.

All are anticipating the announcement soon of a senior civilian deputy to the Director whose office will be in DC and who, presumably, will have direct responsibility for managing and administering the work of the DC-based headquarters. That will likely mean several directorates, including External Communications (public affairs, public diplomacy, outreach, congressional relations/liaison, educational programs, etc.), Policy and Strategy (international relations, domestic education and outreach programs and coordination), P3 (the boundaries have yet to be set, but are inclusive), an Archival Research & Analysis group, and many administrative and oversight requirements.

Chairman’s Comment: Mike Linnington knows he has a very challenging road ahead to earn the trust of a dedicated and talented workforce, as well as add the kind of people he wants and can depend on to move DPAA forward. He is moving NOW and already has learned far more than one would expect after such a very short time in the position. He pledged at the League’s 46th Annual Meeting that he is in this for the long haul and knows it will take time, but asked for support, assistance and patience as he tackles the challenges. I’m convinced that Mike Linnington IS the right guy, and this IS the right time and the best circumstances we, the POW/MIA families, have seen since 1992 to obtain answers we have worked to achieve since the League was formed in 1970.

WOW They sure do add up, Don't they! Thanks Don

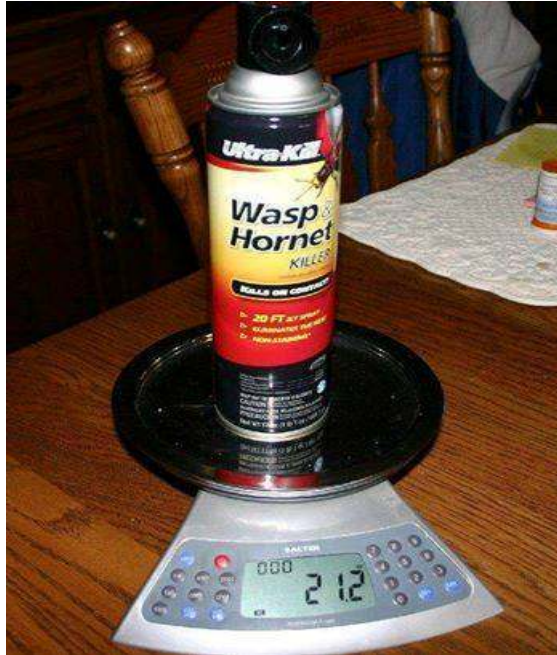


VVA 862 Received “Membership Growth Award” from VVA National

If you don't own, or want, a gun, and even if you do, here's a way to wreck someone's evil plans for you. Did you know this? I didn't. I never really thought of it before. I guess I can get rid of the baseball bat. LOL But seriously, this is great info! Be sure to SHARE!!!

Wasp Spray -- A friend who is a receptionist in a church in a high risk area was concerned about someone coming into the office on Monday to rob them when they were counting the collection. She asked the local police department about using pepper spray and they recommended to her that she get a can of wasp spray instead.

The wasp spray, they told her, can shoot up to twenty feet away and is a lot more accurate, while with the pepper spray, they have to get too close to you and could overpower you. The wasp spray temporarily blinds an attacker until they get to the hospital for an antidote. She keeps a can on her desk in the office and it doesn't attract attention from people like a can of pepper spray would. She also keeps one nearby at home for home protection. Thought this was interesting and might be of use.

On the heels of a break in and beating that left an elderly woman in Toledo dead, self defense experts have a tip that could save your life.

Val Glinka teaches self-defense to students at Sylvania Southview High School . For decades, he's suggested putting a can of wasp and hornet spray near your door or bed. Glinka says, "This is better than anything I can teach them." Glinka considers it inexpensive, easy to find, and more effective than mace or pepper spray. The cans typically shoot 20 feet; so if someone tries to break into your home, Glinka says "spray the culprit in the eyes". It's a tip he's given to students for decades.

It's also one he wants everyone to hear If you're looking for protection, Glinka says look to the spray. "That's going to give you a chance to call the police; maybe get out." Maybe even save a life.

Did you also know that wasp spray will kill a snake? And a mouse! It will! Good to know, huh? It will also kill a wasp!!!

And best of all, immobilize a human.

COMBAT RELATED SPECIAL COMPENSATION (CRSC)

CRSC applies to those that are retired from the service and are receiving military retirement pay, have a VA assigned Service Connected Disability of at least 10% that is attributable actual combat operations, have waived the VA compensation from retirement pay and have filed a CRSC Claim with their specific service branch.

When a CRSC Claim is approved, your VA Disability Compensation will no longer just be deducted from the retirement payments. The VA Disability Compensation amount will be added to the retirement pay received tax free.

The rules and requirements that cover the CRSC program are listed in Title 10 U.S. Code, 1413a and in DoD 7000.14-R, Vol 7B, Chapter 63. These can be viewed by entering either reference into a search engine on the internet.

The CRSC Claim is filed with the individual service branch using DD Fm 2860. It is important to use the DD Form 2860 dated Apr 2008. Do not try to use a DD Fm 2860 dated prior to 2008. The older forms contain a much different Preliminary Criteria that may unnecessarily eliminate otherwise eligible applicants. Follow the instructions precisely. It has been found that the least bit of submission error can result in a claim denial.

Some items within the DD Fm 2860 require some additional explanation: Any documents sent with your claim must be a COPY of the original documents because they will not be returned. Preliminary Criteria supporting documentation required will, as a minimum, include DD 215/215, Military Retirement Orders or Reserve Point Computation, and any VA Disability rating decision documents. The VA documentation must include your service connected disability percentage of 10% or more. The VA decision documentation should include your disability code. Example: VA Code 9411 is for PTSD. The CRSC Office will contact DFAS and your service branch personnel HQ to verify some of the data submitted and to confirm that you are receiving military retirement pay.

The section that covers the Final Criteria requires a much more concise record of your injuries. Purple Heart Recipients must prove that their Purple Heart was as a DIRECT result of armed conflict with specifics in terms of how the injury occurred and any other documented statements that specify the injury was the result of armed conflict, hazardous service, simulated war duties, or as a result of contact with an instrumentality of war. Those that were not awarded a Purple Heart are also required to provide the same types of proof of injury. Just because a person was assigned or was performing duty in a combat zone does not qualify for CRSC consideration. Actual copies of documented proof that the injury was as stated must be submitted. If, for example, you were wounded from shrapnel from a NVA rocket attack, there must be a document to state that you were injured by an NVA rocket. Proof of this situation may show up in a medal citation for the incident or you could be mentioned in a unit morning report that includes the incident. It is up to the applicant to dig up and provide any and all proof to support a claim. If you submit proof, such as, the morning report that you may have received for a unit archive or historical organization, include the addresses and contacts necessary for the CRSC office to verify your documents. If you lost your hearing as a result of an enemy mortar detonating near you, the medical report should state that your hearing loss was the result of a mortar explosion near you. If your disability is the result of Agent Orange, the disability must be stated that it was actually caused by Agent Orange/herbicides. Agent Orange disability is the only Vietnam related disability that will be accepted by the CRSC evaluators as a presumptive causal disability determined by the VA. Gulf War veterans may also get presumptive disability consideration for Mustard Gas and Lewisite exposure disability, as determined by the VA.

It must be noted that in most instances, the employees in the CRSC offices are civil servants and therefore may be limited in their knowledge regarding combat operations. They are bound only by the regulatory guidance provided to them. It should also be noted that there should be no limits for providing the most concise and specific documentation will improve the chance that the claim will be approved.

Study finds links between Agent Orange and Bone Marrow Cancer

Servicemembers exposed to [Agent Orange](#) during the Vietnam War are at higher risk of developing the precursor stage of a bone marrow cancer, according to a study published Thursday in the Journal of the American Medical Association Oncology.

The study provides the first scientific evidence for a link between the precursor stage of multiple myeloma -- a cancer of white blood plasma cells that accumulate in bone marrow -- and [veterans](#) exposed to the herbicide Agent Orange, according to the study's 12 authors, who are associated with medical centers across the U.S. The precursor, called monoclonal gammopathy of undetermined significance, or MGUS, is not in and of itself a problem.

"MGUS is not a cancer," said Dr. Nikhil Munshi, who specializes in multiple myeloma at the Dana-Farber Cancer Institute at Harvard Medical School in Boston. "A very large majority of patients with MGUS remain MGUS all through their lives with no real consequence."

MGUS virtually always precedes multiple myeloma, but the mechanisms that trigger its onset are not fully understood, said Munshi, who was not involved in the study but wrote an editorial published in the same issue of JAMA Oncology.

Previous studies have linked other insecticides, herbicides and fungicides to higher risks of MGUS and multiple myeloma.

Agent Orange was used during Operation Ranch Hand in Southeast Asia to clear jungle foliage from 1962 to 1971. It was usually sprayed via aircraft. Since then, Agent Orange has been linked to a host of health problems and diseases in many servicemembers.

The Veterans Administration maintains a list of "presumptive diseases" assumed to be related to military service that automatically qualify them for [VA benefits](#). The Institute of Medicine has identified seven cancers with a positive association to Agent Orange, including chronic lymphocytic leukemia, Hodgkin lymphoma and non-Hodgkin lymphoma -- all of which have been accepted by the VA as presumptive diseases.

Multiple myeloma is a VA presumptive disease, but it has been classified as having "limited or suggestive evidence" of a link to Vietnam War veterans' exposure to herbicides, the authors of the JAMA study wrote.

The study looked at specimens from two groups of [Air Force](#) veterans that had been collected and stored in 2002 by the Air Force Health Study. A group of 479 veterans who had been exposed to Agent Orange during Operation Ranch Hand were compared with a second group of the same size that had similar duties in Southeast Asia from 1962 to 1971 but were not involved with the herbicide. The Air Force Health Study had sampled servicemembers in the two groups in 1987, 1992, 1997 and 2002 for exposure to Agent Orange and to 2,3,7,8-Tetrachlorodibenzo-p-dioxin, or TCDD, which is an unintended contaminant of the herbicide considered the culprit for so many of its adverse effects.

The researchers found that the prevalence of MGUS in Ranch Hand veterans was twice as high as in the comparison group, with 34 of the 479 Ranch Hand veterans having MGUS compared with 15 out of 479 in the control group.

That translated to a 2.4-fold increased risk of MGUS for Ranch Hand veterans over their counterparts when adjusting for factors such as age, race and other physical traits. "That's an important number," Munshi said. Researchers also found significantly higher levels of TCDD in the Ranch Hand veterans who had developed MGUS, he said.

Because all cases of multiple myeloma originate from MGUS, the study has provided the first scientific evidence for a direct link between Agent Orange and multiple myeloma, he said.
